Notice of Change in Shareholder Benefit Program (Expansion)

Frontier Management Inc. (hereinafter "FMI") has resolved at the Board of Directors meeting held today to change (expand) the shareholder benefit program, and hereby announce it as follows.

Notation

1. Purpose of the change to the shareholder benefit program

FMI appreciates its shareholders for their day-to-day support, and since June 2021 FMI has been offering the shareholder benefits through the Frontier Management Premium Benefit Club. The shareholder reward points system will be changed with the aim of increasing the attractiveness of investment in our stocks.

2. Target shareholders

From December 2024 onwards, shareholders who hold one unit (100 shares) or more at the end of December and June every year.

3. Change in shareholder benefit program

Shareholder benefit points will be presented in accordance with the number of shares held and the number of years the shareholder has continuously held, as shown in the Shareholder Benefit Point Table. The list of shareholders as of the end of December, 2024 onward is applicable.

Exercise conditions: From December 2024 onward, each shareholder shall be listed as a shareholder holding one unit (100 shares) or more in the shareholder register on the last day of December and the last day of June each year.

Carry-over conditions: Only if the same shareholder number is listed in the shareholder register two or more times consecutively on the last day of the following June and on the last day of December (up to three times). If the shareholder number is changed by the vesting date on the last day of June and the last day of December, the shareholder benefit points will expire.

Long-term holdings: "Continuous holdings for three years or more (B)" must be recorded at least seven consecutive times with the same shareholder number in the shareholder register on the last day of June and December of each year.

(NOTE) The number of points is the number of points awarded for each time.
